## President's Message:

During the past month it was my pleasure to travel to South Padre Island with Wanda, RL & Irene Norris where we met Al and Marilyn McCuiston for a few days of shelling. The temperature was great but the sky was overcast and foggy most of the time. We were able to wade the bays and turn rocks and found many of the "normal" shells to be found at SPI. New finds for me were a small *Cymatium parthenopeum* with periostracum and a *Tonna galea*.

There was a significant dredging operation in progress behind the Coast Guard Station which may have impacted the shelling. We hired a boat captain to take our little band to several areas in and around the SPI—Boca Chica area to look for shells but with only marginal success. The boat captain mentioned that there have been several regional waste water treatment plants which have started up the past few years which may also have impacted the marine life populations.

We visited with Mary Hartmann of the SPI Shell Club who made us aware of pending legislation designed to protect the marine life from over collecting. See page 3 for more information. I would encourage you to send an email to Texas Parks & Wildlife and request more information on this issue.

All in all it was a very enjoyable trip. I look forward to seeing you all at the club meeting.

## **Pending Legislation to Regulate Shelling in South Padre**

The following is an excerpt from an email received from a representative of the Texas Parks & Wildlife Department regarding an on-going study of the mollusk population of the bays of South Padre Island. There have been reports of individuals collecting significant numbers of various species for commercial enterprises and this study was conducted to determine if regulation was necessary to protect the future viability of this natural resource. “The Texas Parks & Wildlife Department is making proposals to address concerns over the harvest of live shell bearing mollusks. These organisms are harvested for decorations, arts and crafts and personal consumption among other purposes. While harvest is predominantly recreational in nature, the numbers of organisms harvested are occasionally on the order of commercial operations. Of concern is the long term sustainability of this resource. Characteristics of the species harvested such as relatively long lives, slow movement, localized spawning and the formation of spawning aggregations make them vulnerable to overharvest.

TPWD survey data shows that significant harvest of these organisms occurs at several coastwide locations and is particularly heavy during the fall, winter and early spring on the bay side of South Padre Island near the Brazos Santiago Pass and the Queen Isabella Memorial Causeway. Previous research also suggests that this same area has the highest mollusk species diversity of any area in the lower Laguna Madre.

The Department held scoping meetings with area constituent groups and one-on-one with interested individuals to solicit input on the development of these management measures. Proposals for management measures were presented to the Parks & Wildlife Commission for consideration at the January 26-27, 2005 Commission meeting in Austin. The proposals will be sent out for public hearings after they are published in the Texas Register. A final decision will be made at the April 6-7, 2005 Commission meeting.

I am planning to send out the exact Texas Register language for the proposals, when it is available, to several constituents and can include you in that list if you wish. In the mean time, if I can answer any questions you have, please feel free to contact me.”
